**IF OUR LEADERS (CONGRESS) WILL IMPLEMENT THE BILL 111 INTO LAW, THAN WE, THE MEN AND WOMEN THAT HAVE BEEN SURPRESSED IN OUR EFFORT WILL GET THE OPPORTUNITY TO SPEAK OUT AND BE HEARD IN OUR PLEA TO BRING OUR MEN HOME.**

**THEY—THE POW/MIAs OF WW11, KOREA, VIETNAM AND NOW THE GULF WAR HAVE PAID THE ULTIMATE PRICE FOR OUR FREEDOM.**

**WE—THE MEN AND WOMEN THAT WEAR THE CHAINED EAGLE NOW HAVE A SHOT TO FORCE OUR ELECTED OFFICIALS TO DO SOME THING ABOUT OUR INCARCERATED WARRIORS.**

**THESE OFFICIALS UNDER STAND ONE THING ONLY, THEY FEAR THE LOSS OF YOUR VOTE—JUST MAKE THEM UNDERSTAND THE REASON FOR YOUR CALL, BUT NO THREATS PLEASE.**

**THE GOVERNMENT AND THE PENTAGON HAVE BEEN UNABLE TO DECLARE THE EVIDENCE I HAVE AS ALLEGED, HEARSAY OR FABRICATED, EVIDENCE CONCERNING OUR MEN IN BAMBOO CAGES. IT'S NOW TIME TO SHOW OUR LOYALTY TO OUR UNITED CAUSE AND THE TRUE REASON WE WEAR THE EAGLE. I CHALLENGE EACH AND EVERY ONE OF YOU TO JOIN ME IN THIS EFFORT TO FREE THESE MEN OR REMOVE THE EAGLE FROM YOUR BACK! THEY ARE THERE AND THEY CRY OUT FOR THEIR FREEDOM.**

**THREE MONTHS AGO I WAS INUNDATED WITH CALLS—“PLEASE SEND A CHOPPER” WE’VE GOT MEN WE CAN GET OUT, HURRY”. MY INABILITY TO PRODUCE SADDENED ME DEEPLY, BUT SPURRED MY**

**EFFORT TO GET THE JOB DONE. THIS IS NOT GOING TO HAPPEN AGAIN. I'M GOING TO FIND HELP SOME WHERE OR SOME HOW. THIS IS WHY I NEED YOUR HELP. I HAVE NO INTENTIONS TO TILT ANYONE'S "KITTY". I JUST NEED AN OVERALL EFFORT, MENTALLY, (PRAYER) PHYSICALLY (ON YOUR KNEES) AND LAST BUT NOT LEAST FINANCIALLY (\$????)**

**DONATIONS OF THE PAST HAVE COVERED MY BILLS, PHONES, POSTAGE, PRINTING INK, ETC. BUT THE FUTURE WILL INCLUDE SOME TRAVEL, ESPECIALLY TO WASHINGTON, D.C. YOU WILL BE SURPRISED AT THE NUMBER OF PEOPLE THAT ARE READY TO TESTIFY. MAY GOD BLESS THEM.**

were having enormous rains and flooding that will last a while i am stuck now. that place where i met that man frederic rans i said was in dac lac i made a mistake sorry i met him in binh dinh, in due co close to the border there where the church is located. i have more pictures i will send you as soon as i finish the 30 picture roll then i will send and get them developed. i have some pictures i have scanned and will send you tomorrow, and have sent the hair sample in the mail already be patient the mail is very slow and there is flooding here. samantha is the one that sent my friend the message that he was born in a jewish hospital and trained in ft rucker texas green eyes 6ft. tall and the other info. on my cell phone i gave you was from her. but the problem is she says no arms and the man i met before had one arm then the milliner who says its him has 2 arms and now this one has no arms. as for the stack of pictures i showed you in the hotel room of shelton your sun and so on they have disappeared or were stolen, when i came back to cambodia i took them there to where i always stay when i go and put them all in a disk on my email and i can not recover them i should have given them to you when you asked me i am very very sorry. i spent a lot of time getting them and now theyre gone. john hartley has 6 children boys and girls says he came to vietnam first in 1966 april on hjs tour and attended boston central high school, his adress is 518 louis st., brother name deniss wife sela wilson, father name hartley, speaks no english now because he says hes been here so long and had no one to speak with and the vietnamese gave him a drug that the russians produced to give to all surviving mias to change their identity and make them forget everything, so he decided to start a family and play by the rules and when he has his chance he wants to take it and come home, has been to the embassy once and they did not believe him though he has blue eyes and has a american face. what vietnamese man has those features and tall. as far as those names on the list of prisoners i gave you they said as soon as someone can see who those service numbers i gave you who do they belong to they will let me get dna but i dont know how to find who those service numbers belong to. i am trying to move my operation to laos because theyre not as bad as the vietnamese and its a little bit cheaper to live, everything in vietnam is expensive. theres a foundation called save the akha where they help the tribal akha with mosquito nets and so on and in turn i will get information that i have about a couple of mias with the akha, i am trying to earn the money for a visa to cross the border, thank you for your help your time and all you have done for me, god bless you and take care, jason.

i am trying to earn 200 dollars to go back to kontum for hotel and food, and after that my visa will expire in one week, they are trying to rush me out of here before the results of the blood test for john come, then i am trying to earn 300 dollars to go to laos to move my operation closer to my sources and the men, i work 3 times a week here delivering rice and fruit to the market where they also sell french bread, but the vietnam dong is very little, but i am trying to save every dime. i am also trying to go back to northwest hanoi to thach bai, where i need to rent a boat because the island can only be reached by water and i need some cash to bribe anyone i come in contact with, i want to take pictures of the facility and enter there to meet my source ho long kwon a guard who wants to come to america who has drawn me the map to get there, i need about 200 dollars for that venture, along the way is nghia an where stevens is and my source mr. hop will meet me, and i want to travel to cac bang, ha giang province near the china border where there are vietnam and korean americans in the prison there, but i will meet lan so hacsom who will guide me through the mountain to the camp and my last stop will be dien bien phu where the frenchmen are and i want to help them so much, i ahve someone in the french embassy who said he will help me if i can get them to hanoi where the embassy is, and now i believe the embassy has told the vietcong to watch over me more because they expired my motorbike privileges today even though i paid in full and still have 11 days left to use it, so thats why i must pay for buses. so i am trying to work hard to pay for these trips, though i have 11 days left on visa i want to accomplish this all to be succesful and bring more men to the embassy, you have helped me much and i am grateful and dont want to ask for anything more from you, god bless and talk to you later, jason. the secret questions of peter cressman are for him to answer which i have given to his brother are who was your favorite priest, he answered christopher andrew, who was your childhood war buddy, he answered actor, who was the lady under the kitchen sink, he answered lover, who was friend jaw you broke, he answered seroo:mate, and there was one more question but i cant remember it right now but i told them all to stephen in florida last time i talked to him and he has done nothing, just wanted you to know that, god bless.

im stuck in place far from lam dong because they would not put hartley up until the results and they even would not give me a hotel to stay in saigon even though i told them i drove 8 hours on a motorbike there, hartley or whoever he is, he is frustrated he does not even want to go back all the way there again and he said they did not believe him and has sort of given up coming home, unless there is a helicopter waiting for us or a way to cambodia, they told me to keep quiet until they can identify him and i thought it was strange when three men in black suits who did not look like military analysts for jpac came to interview him, i believe they were cia agents, and they made me feel like i was the enemy, asking me why i came here to look for mias and said i could be charged with spying if vietcong finds out, scaring me and not making me feel good about what i did, and know the keeper of john is angry i had to give him back and its a bad situation, and they said dont contact them well contact you, i have the mans number and names but hesitant because of my security to give now, at least until the blood test comes back, he got really sick on the trip there, but anyways im trying to earn some money here to work on the others while sit men to whatever is they do, hartley was given the russian uh47 injected in him to make him forget his life sort of like r.o.i. program to bring them back with new identities, this is now the second time i have brought hartley or whoever he is to the embassy last time was in 2006 and i have the man who did the interviews name and number i will give you, but at that time they just told me to leave and they would take it from here, and i did not know about any reward, they claimed they did a blood test and he was never in the armed forces and that his mom is vietnamese, though he speaks horrible vietnamese, and he tried telling them he suffered injuries from dropping from a high altitude to the ground and was beaten in the camps, it went in one ear and out the other, bottom line we need a helicopter out!!! i will send you some more pictures as soon as i earn some money to get them developed and have them scanned and sent, right now im waiting on the bus to get me close enough where i can walk home, god bless and i hope mary feels better and you get the dna sample in the mail, jason, please dont send any money you have already sent me so much money and i am very grateful for what you have done already, but i would be lying if i said i could not use some money here, because i
