ANYBODY FOR TOO LONG, WHICH SEEMED WEIRD TO SAY THE LEAST I WENT TO A VIOLAGE HUT THE OFFICIAL MET WITH 4 REAA! Y YOUNG PEOPLE AND IN WALKED A MAN WHO WAS BLEEDING. IVE BEEN HERE SO LONG AND IN RUSSIA WORKING ON THE BRIDGES UNDERGROUND. THEN HE SAIL! PLEASE SE QUIET, TALK LOW, DON'T TELL THE EMBASSY THEY ARE SOLD OUT. THEY WOMT LET ME GO . DONT TELL ANY AMERICAN HERE THEY ARE AGENTS AND ARE MIND CONTROLLED. PLEASE BLYE THEM MONEY AND TAKE ME OUTTA THIS HELL. FLHASE MONT LEAVE ME, OH GOD PLEASE LAM ONE OF LAST MEN STILL HOLDING FOR HELP (SAID ARE THERE OTHERS, HE SAID MOST ARE IN THE CAVES AT SAM NEURA AND UNDERGROUND IN HO CHI MINH UNDER THE EARTH. HE SAID HIS FRIEN. TOM HERT OR HART ESCAPED TO CAMBODIA AND VAN FLEET FROM KORCA, FIGHTING WARTIS WITH ME<u>jBRITISH AND THAILAND MENJAND DONNY</u> WOOD AND HALKA OR FIRDLIKA OR SOMETHING TO - 🗘 THAT EFFECT RAN AWAY, ISAID WHAT IS YOUR NAME HE SAID HICHARD MILLING OR THAT AND HEM !! HE YELLED AS THEYPUT HIM ON THE TRUCK AND STRAPPED HIM DOWN, I HERD HIM YELL TELL MY PARENTS: LOVE THEM PLEASE TELL THEM I WILL STAY ALIVE PLEASE, YOU MUTHERFUCKIN GOOKS GET YOUR HANDS OFF ME ILL KILL YOU, TELL AMERICA FUCK THEM . AND HE I ALIGHED REALLY KRAZY LIKE WE SPEED AWAY AND THE OFFICIAL INBISTED I SUNDFOLDED MYSELF AND I SAID NO IM GOIN TO THE EMBASSY, AND THE WHOLE RIDE TO HOME HE SAID JUST FORGET ABOUT WHAT YOUSAWL, DID THAT MAN SAY ANYTHING TO YOU, I SAID INO HES KRAZY SO HE WOULDN'T SUSPECT ANYTHING. I FOLD HIM IM STILL GOING TO EMBASSY TO VISIT FRIEND. LATER I WENT TO EMBASSY IN LAGS AND TOLD THE INVESTIGATOR THERE A OLDER GUY, TALL ALMOST BALD, HE SAID ON NO THAT WAS A MENTALLY INBANE CANADIAN SOLDIER WHO CHOST TO STAY HERE AFTER WAR, ISAID NO, HE SAID YOU ARE THE ONE WHO IS KRAZY, ISAID IM TELLING THE MEDIA, HE SAY LEAVE OR ILL ARREST YOU FOR SPYING, ILEFT AND WENT TO MY EMPLOYERS TOLD THEM , AND THEY SAY MAYBE ITS BEST WE PART WAYS, AND I WANT TO TIE MY SHOES AND HE SLIPPED SOMETHIONG IN MY DRINK AND SAID WELL HAVE A DRINK OR 2 BEFORE YOU LEAVE, LACTED LIKE I DIDN'T SEE HIM SLIP SOMETHING, LOECLINED AND WAS ON MY WAY HOME TO BRITIAN, BUT WENT TO AMERICA TO VISIT FAMILY HAVENT SEEN IN A LONG TIME, AND I CALLED INFORMATION TO GET THE NUMBER AND CONTACTED THEM I WAS THREATENED AT THE AIRPORT TO NOT TALK ABOUT THE POW OR WELL GET YOU. ISAID IS THAT A THREAT, HE SAID NO A PROMISE WELL KEEP, AND I SAID IM GOING TO MY CONGRESSMEN, HE LAUGHED AND WALKED AWAY, IWAS FOLLOWED GOING TO A COUSINS HOSE AND RECIEVED CALLS ON MY CELL PHONE TO KEEPP MY MOUTH SHUT, MY WIFE SAID SOME MAN KNOCKED ON DOOR AND ASKED FOR YOU WEARING ALL BLACK, AND DEMANDED TO COME IN, SHE CALLED POLICE AND THE MAN JUST TALKED THE POLICE AND HANDED HIM SOMETHING AND THEY JUST UP AND LEFT, WE ARE NOW IN HIDING IN NEW ZEALAND I WILL CALL OP SEND SOMEONE THAT WILL CALL IM SORRY TO THE PARENTS BUT I MADE

SUBJ: Joint Chiefs Resolution Committee Report t69-381; Hearsay of a live United States Prisoner of War in Laos.

- 1. Source Administration DATA.
- Summary: Source, A local Thai business man provided HEARSAY concerning an ALLEGED live POW and former B-52 pilot.
- Source contacted RO (REPORTING OFFICER) on Oct. 11, 1989 and asked for assistance in checking out a name ALLEGED to be that of a LIVE POW in Laos. The name provided source is MILLINER, WILLIAM P. 401745001.
- 4. Source said his contacts in Nakhon Phanom have received information from inside Laos that MILLINER IS ALIVE and can be brought to the THAILAND BORDER. Source said that the people who are inside Laos indicated that MILLINER is a B-52 pilot and they are interested in returning him to the United States for A REWARD.

5. Reporting Officer requested source arrange for a meeting between his contacts in NAKHON PHANOM and the local EMBASSY TEAM. Source declined. SOURCE SAID HE COULD OBTAIN A LETTER written by MILLINER giving background data and his fingerprint card. Source also said he is awaiting the arrival of a U.S. Am FORCE GEN. by the name of HARRY C. ADERHOLT who had recently contacted source concerning a reward system. Source said he will contact his people and attempt to arrange a meeting with the Laotians.

# COMMENTS BY THE AUTHOR:

THIS DOCUMENT WAS SLATED TO GO INTO THE ARCHIVES IN WASHINGTON D.C. AND TO REMAIN THERE FOR 50 YRS. THE RELEASE DATE WOULD HAVE BEEN 2039. A FRIEND IN WASHINGTON MADE A COPY AND SENT IT TO THE MILLINER FAMILY, WHICH THE FAMILY PUBLISHED. THEY WERE ACCUSED OF BREACHING NATIONAL SECURITY. THE DOCUMENT HAS SINCE THAT TIME BEEN DECLASSIFIED.

Milliner is still alive today, being held with 12 other American POWs in that area. Included is a POW that has been with him or closely held by the same Laotian tribe, since both men's pictures have been circulated in the area.

Milliner has been tracked all over Southeast Asia by listening posts stationed in Thailand. Information gained from these radio messages has been marked SECRET and filed away in the Archives in Washington, D.C.

According to that information, the POWs are presently located in a mountainous area on the ever changing border between Laos and Vietnam. This no man's land is in control of local war lords and bandit gangs. All rescue attempts have been unsuccessful.

In 1989 people from this tribe went to the American Embassy in Bangkok, seeking a reward for WO-1 William P. Milliner. They brought substantiating evidence in the form of a photograph, fingerprints, and a letter containing information only close family members would be aware of , as proof of Milliner's identity.

An Air Force Sergeant was assigned the task of working with the tribesmen. He advised them to go home and forget it, no reward...

## Dear Mr. President Obama

Some of my friends here are approaching eighty five years of age, we are forgotten American. I have worked on the pipelines in Russia, railroads and bridges in Siberia, mined the black coal of Vietnam, and recorded my name on the gray walls of secret prisons of North Korea and Communist China. I am West Point, drafted Gl, Marine, Air Force. Navy, Special Forces and civilians, some of us picked up off the streets of European cities. Now there are younger men showing up here from a war in the Middle East.

I have played "musical chairs" under the feet of American trade delegations and gullible politicians in Vietnam, always with hope in my heart that some day, someone will come for me. However, my guards keep assuring me that "we can keep you forever".

I waited at the border of Thailand and nobody came. I was liberated by the Russians from the German camps, taken from the convoys at Big Switch, and left in the deserts of Iraq. Still nobody came. I am hidden behind thousands of blacked out documents, jungle grass, barbed wire, and the cold dark anonymity of national security. My children and grandchildren visit my empty grave at Arlington, touch my name at The Wall, leave flowers and flags at the church cemetery on Veterans Day and Memorial Day, but I am not there. I am said to be <u>KIA,KBNR,MIA</u>, not <u>POW. I HAVE DIED MANY YEARS WAITING</u>, I <u>DIED MANY KINDS OF DEATH AND I STILL</u> LIVE.

I dared to hope my freedom was near when my captors sneered at the subject of Congressional inquiry, when five of ten congressmen agreed I could still be here; Nam, Laos,, North Korea, the Russian Gulags, or Red China.

Yet somebow, when it was over, long after, Truman, Eisenhower, Kissinger and Nixon blinked, in a staring contest with the enemy. I became an urban legend, a myth, a will-othe—wisp companion to the UFO and SASQUATCH SIGHTINGS. I became a loose end that President Carter tied in a Gordian knot of secrecy and lies. "Mr. Veteran" assured my wife and children that, all of us who did not survive were home. With arms spread outward stated, "THERE ARE NO MORE POWS". Nixon's promised aid to the enemy to free us was voted down by a Congress led by Ted Kennedy. Eisenhower's fear of

WW 111, his cover up and totally ignoring the fact that Stalin admitted to holding over 20,000 Americans and maybe as many as 100,000 other Nationalities. Why did he hold Americans??? Eisenhower allowed the White Russians held by the Germans as POWs to migrate to other countries. Stalin considered it a fair trade. General Patton lost his life for being very vociferous about the trade. He stood toe to toe and called the Russian Generals every xxcx290sntyv7dasjhchindin,sywlsssslsm,nbvgkjhdsl,f/pjznmes in the book. Trumans sharing of POW reports with my country's enemies at the United Nations, nailed shut my door to freedom.

My returning campmates debriefings were secreted away "for my personal safety". Mr. PRESIDENT why should a dead man concern himself with personal safety and his privacy? Dead men tell no tales. What personal threat could I be to my homeland after all these years? Do I know something that would be damaging to former leaders? YES I DO AND IT'S TIME YOU MR. PRESIDENT OBAMA AND THE WORLD KNOWS. IT'S NEVER TOO LATE TO START ASKING QUESTIONS.
